AUTHORITY FOR CHILD CARE FEE

10 U.S. CODE 1798



CHILD CARE FEE ASSISTANCE

- The Military Services Child and Youth Programs offer child care fee assistance to their respective civilian employees.
- Based on funding availability.
- Prior to FY23, only Army and Navy offered fee assistance to their civilians.
- In FY23, MC&FP received funding to offer fee assistance to DoD Civilians including DoD Agencies and Field Activities (4th Estate).



MILITARY CHILD CARE IN YOUR NEIGHBORHOOD

Military Child Care in Your Neighborhood (MCCYN) provides authorized active-duty personnel, Reserve Component members, and DoD civilian employees with assistance in locating, selecting, and offsetting the cost of civilian child care when installation child care is not available or not a viable option.

The Military Services and DoD provide child care fee assistance to buy down the cost of community-based child care.

Civilian child care providers must meet DoD eligibility requirements which include:

- State license with annual licensing agency inspections.
- Employee background checks.
- National accreditation or participation in the Department's MCCYN-PLUS initiative.



ELIGIBILITY AND AVAILABILITY

- MCCYN is available to Military Department civilian employees and DoD Agencies and Field Activities.
- Civilians must be full-time employees (30 hours or more per week)
- If married, your spouse must be employed, actively seeking employment, or a full-time student

Employees must be either:

- Employed at a military installation identified as fee assistance eligible, or
- Not living near a military installation with a Child and Youth Program (Geographically Dispersed).



FEE ASSISTANCE CALCULATION

- The amount of fee assistance provided per child is based on:
- The fee a family would pay if receiving care on the installation (standardized across the Department and based on total family income);
- The cost of care charged by the community child care provider; and
- The child care provider rate cap.
- The amount of fee assistance per child is the difference between the family's military child care fee based on Total Family Income and the provider's rate, up to an established rate cap.



FEE ASSISTANCE ENHANCEMENTS

- The Department increased the community-based fee assistance provider rate cap from \$1,500 to \$1,700 per child/per month in Oct 22 and to \$1,800 per child/per month in Jan 24.
- With a higher provider rate cap, families may qualify for higher amounts of fee assistance.



FEE ASSISTANCE: EXAMPLE 1

- A family working in Norfolk, VA with a Total Family Income of \$148,000 (Category X) has a military child care parent fee of \$845 per month/per child. If the child care provider charges \$1,500 monthly (within the established monthly provider rate cap), the parent pays their military child care fee of \$845, and the provider receives \$655 in fee assistance.
- \$1,500 (Provider Rate) – \$845 (Military Child Care Fee)
= \$655 (MCCYN Fee Assistance)



FEE ASSISTANCE: EXAMPLE 2

- If a family chooses a provider who charges more than the established provider rate cap, the family is responsible for any amount in excess of the provider rate cap in addition to their military child care parent fee.



FEE ASSISTANCE: EXAMPLE 2 (CONT.)

- The same family from Example 1 with a Total Family Income of \$148,000 (Category X) chooses a provider that charges \$2,000 monthly, \$200 above the monthly provider rate cap of \$1,800. The parent pays their military child care parent fee of \$845 and the amount above the provider rate cap (\$200) for a total of \$1,045. The provider receives \$755 in fee assistance.
- \$1,800 (Provider Rate Cap) – \$1,045 (\$845 Military Child Care Fee and \$200 amount above the rate cap)
- = \$755 (MCCYN Fee Assistance)



REQUESTING CHILD CARE

- Families must use MilitaryChildCare.com (MCC), a secure DoD gateway to military-operated and eligible civilian child care options, to request care and search the full range of programs that meet their specific care needs in their preferred location.

Military Child Care in Your Neighborhood (MCCYN) is a DoD and U.S. Coast Guard fee assistance program for eligible families who cannot access military-operated child care due to distance or waitlists. With fee assistance, a portion of your child care costs is paid to offset the costs of community-based care. This makes it easier for families to afford quality child care from local community providers.
