## Background

In December 2021, Department of Navy discovered a number of civilian employees were potentially placed in the wrong Federal Employee Retirement System (FERS) plan. There are three different FERS plans with differing employee contribution rates: FERS, FERS - Revised Annuity Employees (FERS-RAE), and FERS – Further Revised Annuity Employees (FERS-FRAE). FERS requires an employee contribution rate of 0.8% of basic pay and generally covers employees appointed on 1 January 1984 through 31 December 2012. FERS-RAE requires an employee contribution rate of 3.1% of basic pay and covers employees appointed on 1 January 2013 through 31 December 2013. Finally, FERS-FRAE requires an employee contribution rate of 4.4% of basic pay and covers employees appointed on 1 January 2014 to present.

A subsequent audit has found some federal employees serviced by the Defense Finance and Accounting Service's (DFAS) Human Resource Office (HRO) are also in the wrong FERS retirement system. You are receiving this guide because you are included in this group. A thorough review of the identified personnel files confirmed some personnel files contained retirement coding errors causing the employees to be placed in the wrong FERS retirement plan. In the majority of instances, the error caused underpayment of FERS retirement contributions and overpayment of salary, resulting in an employee debt to the government.

Title 5 of the Code of Federal Regulations (C.F.R.) Section 841.505(d) states any portion of the payment to the FERS retirement fund which should have been deducted, but was not, from employee basic pay constitutes an overpayment of pay, subject to collection by the agency from the employee unless waived under applicable authority.

To give impacted employees awareness of the unavoidable decrease in take-home pay that would occur upon correction of the error, DFAS HRO notified employees of the error on June 27, 2022, and completed processing corrections to employee records June 29, 2022. These corrections were provided to DFAS Civilian Pay Offices for further processing. DFAS Civilian Pay Offices are reviewing payroll records, correcting retirement codes, determining overpayments and issuing debt notification letters to affected employees.

DFAS will begin sending debt notification letters as each case is reviewed and debt amounts are established. This process is anticipated to take several months.

The employee's receipt of the debt notification letter is the triggering event for the employee's exercise of options concerning debt management. Employees have one of three options: 1) to repay the debt; 2) file a request for waiver of the debt; or, 3) file a hearing request to contest the validity or amount of the debt.

On July 1, 2022, DFAS approved a request to suspend collection of these debts for a period of six months beginning the date your debt notification letter is mailed to you.

## Overview

Generally, persons who receive a payment erroneously from the Government acquire no right to the money, and they are required to make restitution. If a benefit is bestowed by mistake, no matter how careless the act of the Government may have been, the recipient must make restitution. In theory, restitution results in no loss to the recipient because the recipient received something for nothing. However, Title 5 of the United States Code (U.S.C.) Section 5584 provides authority to waive, under certain conditions, debts individuals owe the Government that are the result of erroneous payments of pay and allowances. A waiver is not a matter of right. It is available to provide relief as a matter of equity, if the circumstances warrant. Pursuant to 5 U.S.C. 5584, waivers may be granted only if the authorized official determines that collection of the debt would be against equity and good conscience and not in the best interests of the United States. Generally, this standard is met if there is no indication of fraud, misrepresentation or lack of good faith on the part of the employee. A waiver is normally precluded if the employee knew or had reason to know that an erroneous payment occurred.

The amount of the employee's debt determines who has waiver authority. The DoD waiver approval authority for debts \$1,500 and under is the Director of DFAS-Indianapolis. For debts over \$1,500, the DoD waiver approval authority is the Director of the Defense Office of Hearings and Appeals (DOHA). However, all waivers are initially routed through DFAS regardless of which office holds the waiver approval authority.

This Waiver Guide was developed to assist you with filling your waiver applications and assembling their waiver packages. The DFAS HRO is also available to assist with questions, obtaining supporting documentation, reviewing packages for completeness, and serves as the collection point for all retirement contribution error waiver packages. ## Building the Waiver Package

### Step 1 – Filling Out the Waiver Application Form (DD Form 2789)

Employees have two options for filling out the DD-2789. Go to the DFAS website at <https://www.dfas.mil/waiversandremissions/civilianwaivers/> and you will see that you have the option to download a fillable PDF DD Form 2789, or you may use the DD-2789 Smart Form.

We **highly recommend** using the Smart Form because it is easier to fill out, and walks you all the way through the form to completion.

**Current or Former Civilian Employees**  
A waiver is an act of the government to intentionally relinquish its claim against an individual for a debt resulting from erroneous payments of wages or allowances. Financial hardship is not a consideration for waiver. Civilian claimants must submit a waiver application to DFAS within 3 years of the date the debt was discovered by a pay official.

Civilian employees are not eligible for Remission because their debt was not incurred while on active duty military orders.

**How to submit**  
You may request a waiver by completing the [DD Form 2789 \(PDF\)](#) or [DD2797 \(smart form\)](#) Remission/ Waiver of Indebtedness Application. To be eligible for waiver you must submit your waiver request within 3 years from the date the debt was discovered by an appropriate official.

To apply for a waiver you must:

- Have a debt established on your pay account.
- Submit your application to your civilian payroll office within 3 years of the date the debt was discovered by a pay official.
- Agree to the validity of the debt. If you dispute the debt, you can ask your servicing finance or payroll office to conduct an audit before you proceed with the application process. Former employees must contact the Civilian Payroll Office at 800-729-3277 to request an audit. You can pursue a waiver once your audit is complete. Please ensure that you attach the results of your audit, and a statement acknowledging the validity of the debt, with the waiver application.

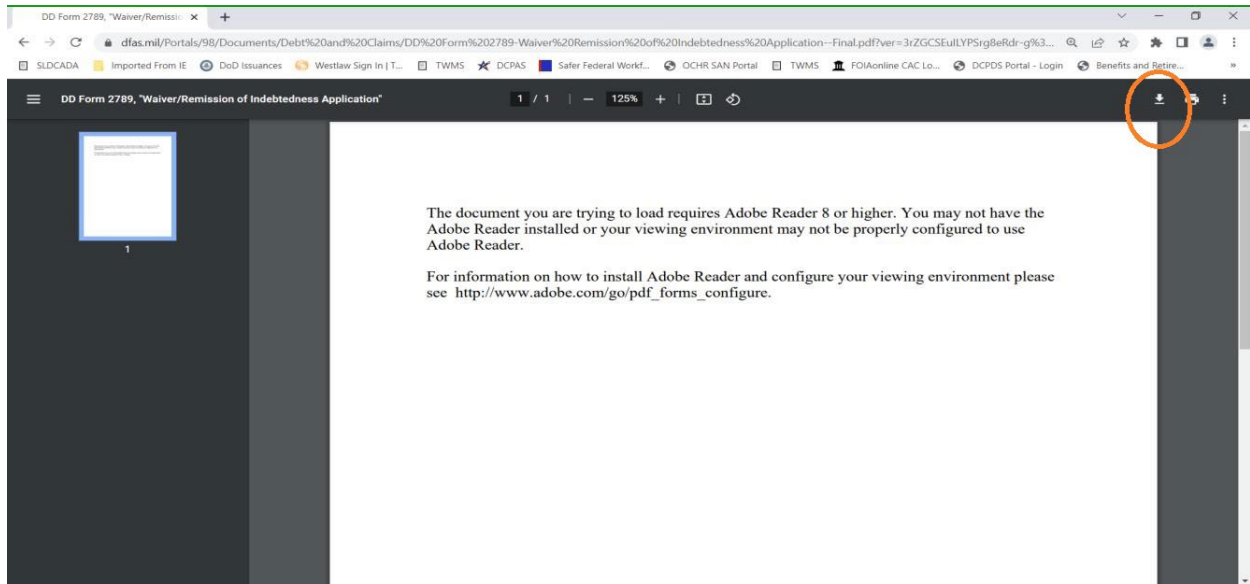
Active and former civilian employees must complete the first page of the [DD Form 2789 \(fillable PDF\)](#) or [DD 2789 \(smart form\)](#). Once complete, submit the application to the address listed on the debt notification letter.

If you did not receive a debt notification letter, you may call the Civilian Payroll Office for a copy at 800-729-3277.

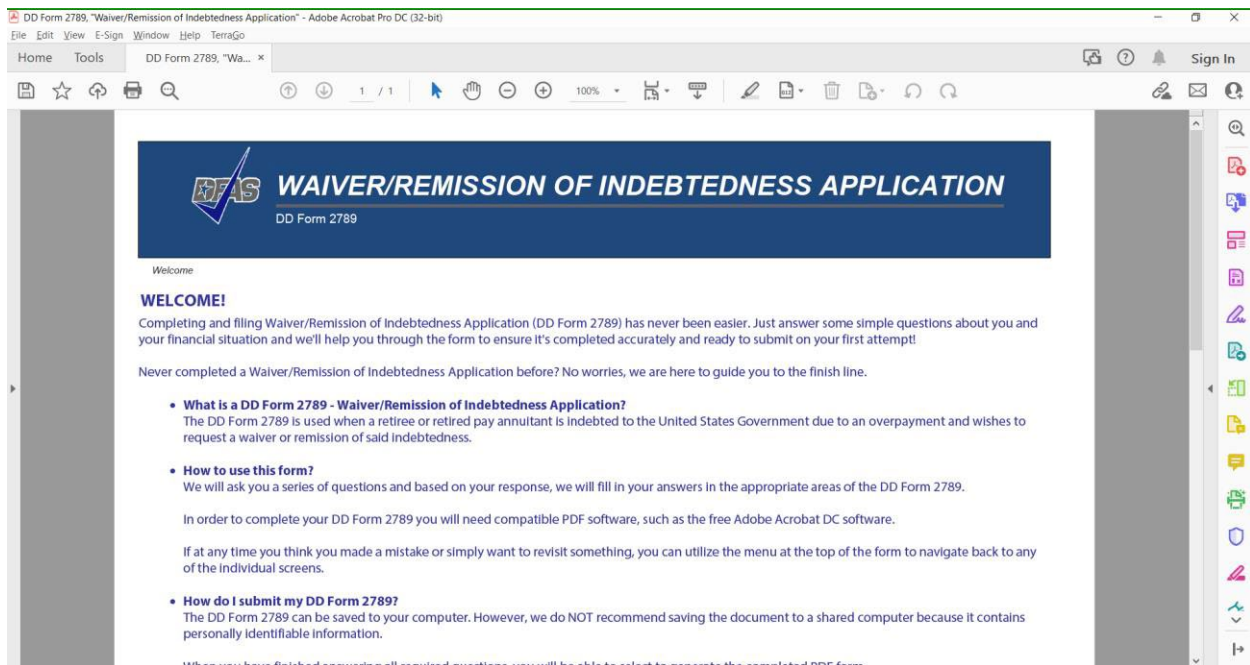
Documents you should include with your application:

**Option 1:** Download a fillable PDF version of the DD Form 2789 by clicking on the **second link** to the DD Form 2789 (fillable PDF), towards the bottom of the How to Submit Section of the page (circled below in **blue**); OR,

**Option 2:** Download the DD-2789 Smart Form by clicking the smart form link (circled above in **black**). We highly recommend using this option for your waiver application. When you click on the link to the Smart Form, you may receive the following message:



**Do not worry about it!** Click the download button (the downward pointing arrow) near the top right corner of the document circled above. You will be asked to save the file to your computer, save the downloaded file on your computer wherever you like. After you save the file, a PDF form icon will appear at the bottom left corner of your screen. **DO NOT** click the icon – it will take you back to the same Adobe Reader 8 message you see above. Close the webpage, then go to where you saved the smart form on your computer. Double click the Smart Form to open it and below is what you should see:



Whether you choose Option 1 (fillable PDF) or Option 2 (Smart Form), you are now ready to fill out your waiver application. Both options require you to provide the same information, but the questions will appear in slightly different order.

If you don't know how to answer a particular question, Appendix A of this Guide contains a complete copy of the DD-2789 fillable PDF form (including the instructions).

In addition to the instructions contained in **Appendix A**, below is some general guidance to assist you in filling out Section I of the DD-2789 waiver application form.

### **Waiver Application Form - Section I:**

- Type of Claim: Waiver
- Rank/Grade: Current GS Grade or Equivalent
- Status at the Time of Debt: For current employees, status is "DoD Civilian".
- SCD: For current employees, the SCD is the **Civilian SCD**. Note, this is NOT the SCD reflected in Block 31 on your SF-50. The SCD reflected on the SF-50 is your SCD Leave date. You must use the SCD Civilian date for your waiver application. You can find your SCD Civilian date by logging into MyBiz at <https://compo.dcpds.cpmis.osd.mil/>. When the home page opens, scroll down to the "Detail Pages" section at the bottom of the page and click on the purple box titled "Personal." From the menu, select Service Computation Date Information.
- There you will see your SCD Civilian date; use this date for your waiver application form.
- Mailing address, e-mail, home phone: It may take over a year for DFAS/DOHA to issue a decision on your waiver application. Make sure you use mailing addresses, phone numbers and e-mail addresses that are most likely to be accurate and still in use a year from now.
- Place of Assignment: Name and address of your current command
- Type of Debt or Erroneous Payment: Erroneous overpayment of salary due to FERS retirement coding error.
- Reason for Requesting a Waiver: When writing your statement, you are advised to keep in mind the standards for granting a waiver. The standards for considering waiver are outlined in 5 U.S.C. §5584 and DoDI 1340.23, Enclosure 4, which are posted online at [5 U.S. Code § 5584 - Claims for overpayment of pay and allowances, and of travel, transportation and relocation expenses and allowances | U.S. Code | US Law | LII / Legal Information Institute \(cornell.edu\)](#) and <https://www.esd.whs.mil/Portals/54/Documents/DD/issuances/dodi/134023p.pdf> respectively.
- Key considerations are:
  - Waivers will not be granted if there is any indication of fraud, misrepresentation fault, or lack of good faith on the part of the employee.
  - A waiver is generally precluded if the employee knew or reasonably should have known that an erroneous payment occurred (i.e. an unexplained significant increase in pay).

- The fact that an erroneous payment is solely the result of an administrative error or mistake on the part of the Government is not sufficient basis in and of itself for granting a waiver.
- HRO POC: Contact the individual at your HRO identified in your notification memo.
- Employee Signature: **Employees must sign the waiver application form using either their CAC digital signature, or by physically signing the form using their handwritten “wet” signature.** No electronic signatures, other than CAC digital signatures, will be accepted.

### Waiver Application Form - Section II:

- 1) Employees are NOT responsible for completing Section II of the waiver application. DFAS will complete Section II.

### Step 2 – Gather Required Supporting Documents

All waiver applications must be accompanied by supporting documentation. At a minimum, your waiver package is required to include the following documents:

1. **Completed and signed** Waiver/Remission of Indebtedness Application DD Form 2789. Again, the form must be signed using either a CAC digital signature, or by physically signing the form using a handwritten “wet” signature.
2. Notification Letter you received from DFAS, and any other notices you may have received notifying you about an error in your retirement code.
3. DFAS Debt Notification Letter
4. Standard Form 50s (SF-50s): Copies of all SF-50s issued during the entire debt period. Also include at least one (1) SF-50 *BEFORE* the error occurred (if any). You must also include the correction SF-50 correcting Block 30 of your SF-50 (moving you to the correct retirement plan), and one SF-50 *AFTER* the error correction (if any). Employees may access their SF-50s in one of three ways:
  - a. By logging into MyBiz at: <https://compo.dcpds.cpms.osd.mil/rsouiportal/AccessRegions.jsf>; or
  - b. By logging into eOPF at <https://eopf.opm.gov/dfas/>. Employees who do not have an eOPF account can download the instructions from the eOPF website at: <https://eopf.opm.gov/dfas/LoginFAQs.htm> and <https://eopf.opm.gov/dfas/LoginHelp.htm>. Employees who have established an eOPF account are encouraged to review **Appendix B**, which contains instructions for easy download of all or part of an eOPF in one batch.
  - c. If the retirement code error occurred upon your **initial appointment** to Federal service, you do not have SF-50s from before the error occurred. If this applies to you, you will need to provide a statement explaining why you have no SF-50s to provide for the time period before the error. See the sample statement provided at **Appendix C**.



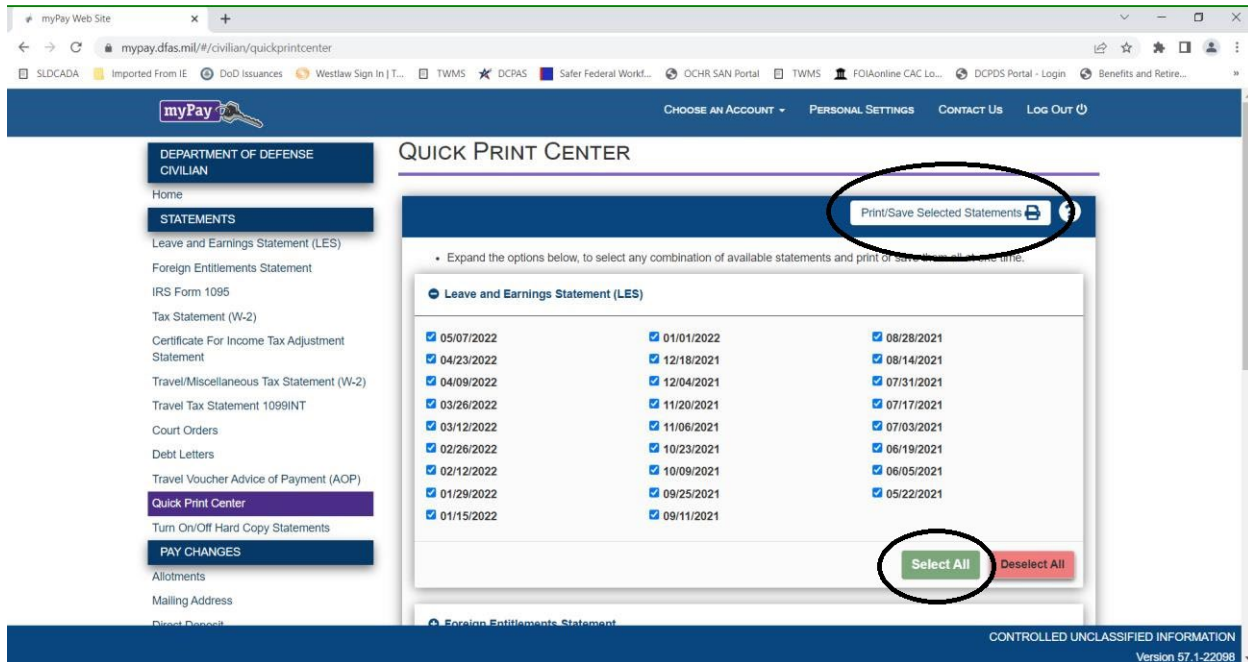
5. Leave and Earning Statements (LES): Copies of all LESs issued during the entire debt period. You must also include three (3) LESs *BEFORE* the error occurred (if any), and three (3) LESs *AFTER* the correction to your retirement code was made (the deductions section of the LESs will show the retirement plan and code)

Employees are **REQUIRED** to provide copies of all relevant LESs available in myPay. Employees may download their LESs by logging into the myPay website at <https://mypay.dfas.mil/#/>.

Next, click on Leave and Earning Statement (LES). A box will open listing all the LESs available for download, click the “select all” button at the bottom right of the screen, then go up to the top of the box and select “print/save selected statements”.



A PDF containing all your LESs will open. Click the download button (the downward pointing arrow) near the top right corner of the document. You will be asked to save the file to your computer, save the downloaded file on your computer wherever you like.

- a) **Your waiver package must include ALL LESs in your possession that are within the debt period.** If you save your LESs, you are expected to include all LESs in your possession that fall within the debt period in your waiver package.
  - b) **LES documents available on myPay only go back 1 year (26 pay periods).** Employees who do not have copies of their older LESs are required to provide a statement explaining why your package is missing your older LESs. A sample statement is provided at **Appendix C**. DFAS will retrieve any missing historical pay records that are over one year old and will add them to your waiver application package.
  - c) If the retirement code error occurred upon your **initial appointment** to Federal service, you do not have LESs from before the error occurred. If this applies to you, you will need to provide a statement explaining why you have no LESs. See the sample statement provided at **Appendix C**.
7. Employees must provide a statement as to why you are requesting a waiver and why you think it should be approved. See the sample statement provided at **Appendix C**.
  8. Employees must include any other documents they make reference to in their Waiver Application form DD-2789.
  9. If an employee states in their Waiver Application that they were given incorrect advice by someone in HR or makes reference to something another person told them that they relied on, the employee must include a signed statement from that person confirming what was said. See the sample statement provided at **Appendix C**.

### Step 3 – Assembling Your Waiver Package

All waiver packages should be organized in the following order:

- Tab 1 - Completed and signed Waiver of Indebtedness Application DD Form 2789
- Tab 2 - Notification Letter you received from DFAS Human Resources, and any other notices you may have received notifying you about an error in your retirement code.
- Tab 3 - DFAS Debt Notification letter
- Tab 4 - SF-50s for entire debt period (and missing document statements – if applicable)
- Tab 5 - LESs for entire debt period (and missing document statements – if applicable)
- Tab 6 - Employee statement why waiver should be approved
- Tab 7 - Documents you referred to in your DD-2789 Waiver Application Form – other than those covered under Tabs 1-7 (if any)
- Tab 8 - Witness statements (if any) Tab 10 - (Optional) Any other documents that you believe support your waiver application (other than those covered under Tabs 1-7)

#### Package Requirements:

- **All documents within each tab are required to be arranged in chronological order by date from the earliest date to most recent.** In other words, all SF-50s in Tab 5 and all LESs under Tab 6 must be arranged in chronological order. For example: LES - 1 Jan 2015, LES - 5 July 2016, LES - 9 Aug 2018, LES - 2 Jun 2020, etc.
- **Each tab must start with a tab separator sheet found in Appendix D.** All documents belonging under that tab should be arranged in chronological order by date from the earliest date to most recent behind the tab separator sheet.
- All waiver packages must be submitted with a Privacy Act cover sheet on top. **Appendix E**
- **Double-check your waiver package** using the checklist at **Appendix F** to make sure your waiver package is complete before filing!
- **Scan ALL documents together to make one (1) single Waiver Package. See example waiver package at Appendix G.** For packages over 150 pages in length, see electronic filing instructions below.

### Step 4 – Filing Your Waiver Package

Employees have two (2) options for submitting their waiver packages.

Option 1 – Electronic Submission (unless no scanner access)

Option 2 – Hard-Copy Submission

**For tracking purposes, it is STRONGLY RECOMMENDED that all impacted employees file their waiver packages via DoD SAFE to [dfas.indianapolis-in.zhs.mbx.tech-services-team@mail.mil](mailto:dfas.indianapolis-in.zhs.mbx.tech-services-team@mail.mil).** The ONLY exceptions should be for employees who do not have access to a scanner at work or

at home. These employees will be permitted to file their waiver packages with the DFAS HRO in hard-copy.

#### **ELECTRONIC FILING:**

1. **ALL waiver packages under 150 pages in length should be scanned together to make one (1) single PDF Waiver Package document.** See example waiver package at **Appendix G**. Packages over 150 pages in length should be broken down into 2 or 3 pieces and scanned and saved separately.
2. All electronic waiver packages are **REQUIRED** to be submitted via DoD SAFE to the DFAS HRO POC designated to receive waiver packages.
  - a. DoD SAFE file size **is limited to 8 gigabytes (GB) per transfer**. 8 GB is a very large file size, however waiver packages over 150 pages in length should be broken down into 2 or 3 pieces and transmitted separately to ensure you do not exceed the file size.
  - b. The email box <mailto:dfas.indianapolis-in.zhs.mbx.tech-services-team@mail.mil> is monitored by human resources specialists who will send waiver requests to DFAS Civilian Pay, and can assist with questions, obtaining supporting documentation, reviewing packages for completeness, and serve as the collection point for all retirement contribution error waiver packages.

**NOTE:** All impacted employees have the option to file their waiver application packages directly with DFAS in accordance with the instructions provided in the DFAS debt notification letter.

3. **BEFORE you begin scanning your documents, CHECK THE SCANNER SETTINGS!**  
Changing the scanner settings to the following will help to keep the file size to a minimum.
  - a. If the default setting is color and/or photo, change the settings to scan in black and white **TEXT**. **Do NOT use the photo/color setting!** Using the Text setting produces significantly smaller file sizes than the photo setting.
  - b. Set the resolution to 200 dpi.
  - c. If you are scanning documents that are single-sided, then make sure the scanner is set to scan single-sided. Likewise, if you are scanning documents that are double-sided, then make sure the scanner is set to scan double-sided.
  - d. If you are scanning a mix of double-sided and single sided documents, please change the scanner settings accordingly as you scan.
  - e. If the scanner is not actively being used, after a few minutes, it will go back to the default scan settings. **ALWAYS re-check the scanner settings between batches!**
4. It is recommended that you name your file(s) in the following format to ensure they are routed for proper processing: [Waiver Request\\_FERS\\_\(Your Last Name\).pdf](#).
5. To access DoD SAFE go to: <https://safe.apps.mil/> and select your authentication certificate. On the DoD SAFE home page, click on Drop-Off (see below)

In the Note box, type in your name and “waiver package” as shown above.

You also need to click the box at the bottom of the page confirming that your upload does NOT contain any classified information.

**Next, click ALL the boxes to the right.** This will ensure you receive an e-mail when the drop-off is complete, and more importantly, when the recipient (DFAS HRO POC) picks up your drop off.

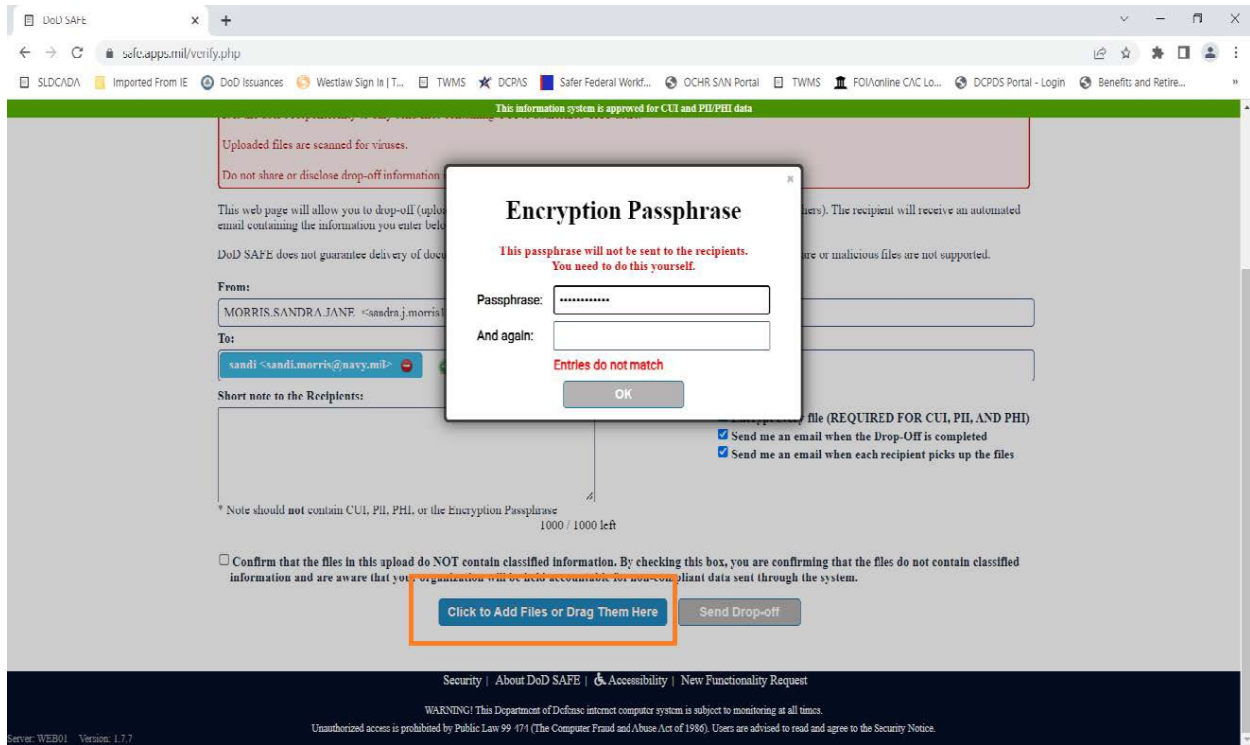
**Save the e-mail confirming the HRO POC picked up your drop off as PROOF of filing your waiver package.**

When you click on the box to encrypt every file, a dialogue box will open asking you to enter a passphrase (i.e. password). The passphrase must be at least 10 characters in length.

When you type in the passphrase, you will get a message that the entries do not match (see below).

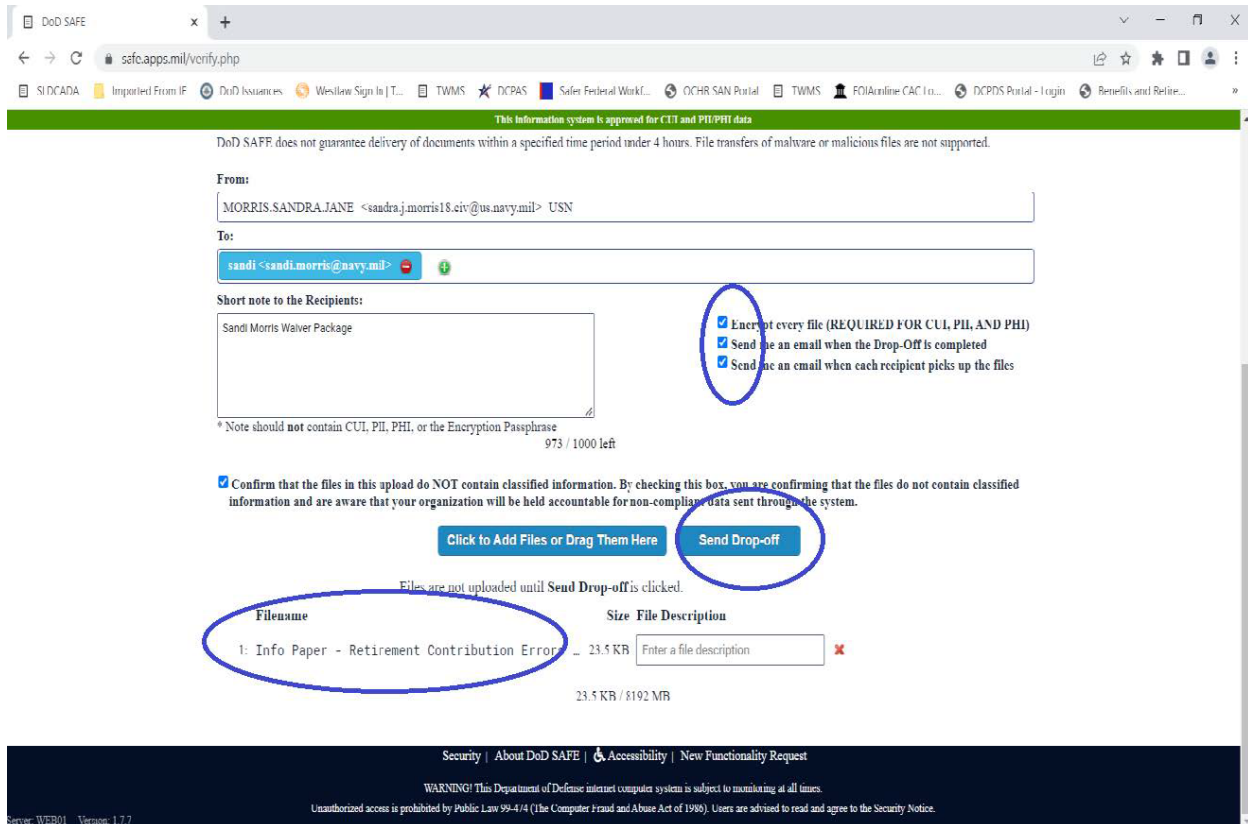
That’s ok. The message will go away when you type in the passphrase again.

Note - If you have to break your package into pieces because your waiver package exceeds the 8 GB file size, you can re-use the same passphrase for each transmission.



After you enter the passphrase again, click on the blue box at the bottom of the page titled "Click to Add Files or Drag Them Here" to upload your waiver package. The uploaded file will appear at the bottom of the screen under Filename (circled below).

Double-check to make sure all 3 boxes to the right are all checked. Then click "Send Drop-Off"



**NOTE - DoD SAFE does not e-mail the passphrase to the recipient – you must do this yourself!** After you drop off your package, you must go into Outlook and e-mail to the DFAS HRO POC ([dfas.indianapolis-in.zhs.mbx.tech-services-team@mail.mil](mailto:dfas.indianapolis-in.zhs.mbx.tech-services-team@mail.mil)) with the passphrase (password) so the POC can download and open your waiver package. Once the HRO POC accepts your file, you will receive an email confirmation. Please save this email as your confirmation of delivery.

### HARD-COPY FILING:

Hard-copy filing should only be for employees who do not have access to a scanner at work or at home.

1. Print out all documents and assemble in the order outlined in Step 3 above, to include Tab Separator Sheets and Privacy Act cover sheet.
2. Double-check your package by completing the checklist at **Appendix F**
3. Make a complete copy of your waiver package to keep for your files!
4. Mail the waiver request package to:

5. Upon receipt, DFAS HRO will send email confirmation via the email address you provide on your DD Form 2789 (Waiver/Remission of Indebtedness Application). **Save the email receipt in your waiver request file.**

### **Step 5 – Waiver Package Status**

You have now completed and filed your waiver. It may take up to a year or more before an initial decision is made on your waiver application. You will receive a written notification of the waiver decision when the waiver authority has completed adjudication of your waiver application.

The amount of the debt determines who has waiver approval authority. The waiver approval authority for debts \$1,500 and under is the Director of DFAS-Indianapolis. For debts over \$1,500, the DoD waiver approval authority is the Director of the Defense Office of Hearings and Appeals (DOHA).

For status updates on your waiver package, please email the DFAS HRO (dfas.indianapolis-in.zhs.mbx.tech-services-team@mail.mil). The DFAS HRO will obtain a status for you. As stated above, the waiver adjudication process can take up to a year or more. In light of this, please limit the frequency of your status inquiries to once every four (4) months.

## eOPF Tips & Techniques

### Search, View, Print, and Save Documents Using My eOPF

#### Introduction

The electronic Official Personnel Folder, or eOPF, manages all personnel documents, organized by virtual folders. The Permanent and Temporary virtual folders contain documents in accordance with OPM's *Guide to Personnel Recording Keeping* (located at: <http://www.opm.gov/policy-data-oversight/data-analysis-documentation/personnel-documentation/>).

#### Useful Features

##### **My eOPF** button:

Lists the details associated with your eOPF and your documents. By clicking the **My eOPF** button, you can access subject tabs which will appear at the top of the screen.

##### **My eOPF Search** page:

While you do not have to use these filters, they can help narrow search results. Available search fields include:

**My eOPF Print Folder** page:

Enables you to select a folder side(s) and create a printable file. This function compiles all of the individual documents saved to the selected folder side(s) to one consolidated PDF file which can be found on the print status page.

**My eOPF Print Status** page:

Provides a list of print requests that you have submitted, displaying in the order in which they were submitted. Each print request is assigned a Request Identification (Request ID) number. Depending on the size of a request, a print job may be broken into two or more parts. A password is required for access.

**New Security Feature for Print Requests**

If you want to print several documents at once, or an entire eOPF, you will first make a print request. The completed request is accessed from the print status page. Before you can view, save or print a print request, you must enter a password unique to your request. Instructions about the password function are included in this document, in Part 5, and also on the print status pages of the eOPF application.

SUBJECT: Notice of Federal Retirement Plan Contribution Error

A recent review of your official personnel record revealed an error involving the retirement contribution code associated with your federal retirement plan. The error resulted in salary overpayment and corresponding debt to the federal government for underpayment of retirement contributions. This letter contains information about the error and the steps that will be taken to correct the error as well as the process to assess and address the likely debt.

There are three different Federal Employee Retirement System (FERS) programs with differing employee contribution rates: FERS, FERS - Revised Annuity Employees (FERS-RAE), and FERS - Further Revised Annuity Employees (FERS-FRAE). FERS requires an employee contribution rate of 0.8% of salary and generally covers employees appointed on January 1, 1984 through December 31, 2012. FERS-RAE requires an employee contribution rate of 3.1% of salary and covers employees appointed on January 1, 2013 through December 31, 2013. Finally, FERS-FRAE requires an employee contribution rate of 4.4% of salary and covers employees appointed on January 1, 2014 to present.<sup>1</sup>

Your most recent Notification of Personnel Action (SF-50) indicates your retirement contribution code is:

The net effect of this error is that you had less money deducted from your pay than was called for under your applicable FERS program, resulting in an overpayment of salary and underpayment of retirement contributions. DFAS HR has corrected this mistake with a personnel action that will ensure contributions in future pay periods are accurate. The correction will also

address past actions up to the present day. After the correction to your personnel record is processed, the correct deduction will be used for all future salary payments.

Federal regulations require the DFAS Civilian Pay Office to notify employees of actions that may cause indebtedness. Separate from and in advance of that required notification, DFAS HR decided to provide you with this notice of the error and pending corrective action.

Our office has processed corrective actions through the Defense Civilian Personnel Data System to DFAS Civilian Pay; however, it may take some time to complete the process, since the actions require detailed processing by DFAS Civilian Pay.

You will receive notification from the DFAS Civilian Pay Office concerning the error. We recommend you contact the DFAS Civilian Pay Office at the number provided in their letter for information regarding any debt amount that is owed, payment plan options, and a debt challenge or waiver request process.

We regret the inconvenience this corrective process will cause you. If you do not repay the debt in full, or do not submit the Voluntary Repayment Agreement within 30 days from the date of this letter, DFAS must collect the debt using other collection procedures. Beginning on July 02, 2022, DFAS will initiate collection of the debt involuntarily from your pay by using salary offset procedures. DFAS estimates that based on your current payroll information, your available disposable pay is \$1,745.13 and 15% of your disposable pay is \$261.77. Repayment of the principal amount of your debt would be completed in approximately 37 pay periods. If you retire or resign before your debt is paid in full, the entire amount of your final pay (salary and lump sum payments) may be applied to pay off your debt.

**Opportunities Available to You** If appropriate, you may contact your timekeeper to make time and attendance corrections, or your personnel office to make pay or allowance changes. You may inspect and/or receive copies of DFAS records related to your debt by contacting DFAS at the address above. If you question the validity or amount of your debt, you may request a hearing. If appropriate, you may request a waiver of your debt. You can find additional information on hearings and waivers at [www.dfas.mil/civilianemployees/debt](http://www.dfas.mil/civilianemployees/debt). DFAS will promptly refund to you any amounts you have paid or that were deducted for your debt which are later waived or found not owed to the United States Government.

**COLLECTION OF YOUR DEBT**

Please be aware of the following additional information concerning the collection of your debt:

**Interest and Additional Charges** If you are unable to pay the debt in full within 30 days from the date of this letter, any unpaid portion of the debt will be considered delinquent. DFAS is authorized by law to add interest, penalties, and administrative costs to your debt if it is not paid within 30 days from the date of this letter. The rate of interest charged is at the Treasury Tax and Loan Rate and may commence on the date your debt becomes delinquent and may continue until the debt is paid in full. Additional penalties may be imposed at the rate of up to 6% a year on any unpaid portion of your debt that is delinquent for more than 90 days, commencing on the date your debt becomes delinquent and continuing until the debt is paid in full.

**Collection Action on Delinquent Debts** If DFAS is unable to collect your debt by salary offset, DFAS may enforce repayment of your debt by using other available collection remedies such as referring your debt to a private collection agency, reporting your debt to a credit bureau, garnishing your non-Federal employment wages, or referring your debt to the Department of Justice for litigation. Debts delinquent for more than 180 days are transferred to the Department of Treasury for collection. Treasury may offset your Federal income tax refunds or other Federal benefit payments, such as Social Security and Federal employee retirement benefits, in order to collect your debt. You may also be prohibited from being approved for a Federal loan if you do not resolve your outstanding delinquent debt.

**Tax Considerations** Pursuant to IRS Publication 15, income tax withheld by DFAS in a prior calendar year cannot be adjusted. Therefore, if your overpayment occurred in a prior calendar year, you must pay back the gross amount of your debt, including any taxes previously withheld and paid on your behalf to the IRS. You may be entitled to a deduction (or credit in some cases) for the repaid wages on your income tax return for the year of repayment of your debt. Each January, DFAS will issue a tax certificate for amounts repaid toward a prior year debt that can be used for tax filing. If your overpayment and repayment both occur in the same calendar year, DFAS will be able to adjust your tax withholding and you will be responsible for repaying only the net overpaid amount. Upon repayment in the same calendar year, your W-2 will be adjusted to reflect your income and the associated taxes. Finally, please be aware that should your debt repayment ever become delinquent and collected by the offset of your tax refund, your spouse may file Form 8379, Injured Spouse Allocation, with the Internal Revenue Service (IRS) to claim his or her share of the tax refund.

**Collection of Federal Employee Health Benefit (FEHB) Premiums** Your debt may be the result of your being on leave without pay status (LWOP) when your employer paid your FEHB premiums at your request. When you return to employment, or upon your pay becoming sufficient to cover the premiums, you are required to reimburse your employer for the premiums paid on your behalf. If you pay your debt with after-tax dollars using a personal check, the payment will not be subject to pre-tax treatment that would reduce your taxable income. In order to ensure the repayment will be treated on a pre-tax basis, you must select payroll deduction as your repayment method. Pursuant to OPM regulations under the 5 C.F.R. 890.502, the "catch-up" option for repaying your FEHB premiums may not be paid pursuant to a Voluntary Repayment Agreement. Premiums must be collected back each pay period at the rate your employer paid the premium for you.

**Penalties for False or Frivolous Statements** Please be advised that if you make or provide any knowingly false or frivolous statement, representations or evidence with respect to your debt, you may be liable for penalties under the False Claim Act (31 U.S.C. §§ 3729-3731) or other applicable statutes, and/or criminal penalties under 18 U.S.C. §§ 286, 287, 1001, and 1002, and other applicable statutes. A Federal employee may also be subject to disciplinary procedures under 5 U.S.C. Chapter 75 or any other applicable statutes or regulations.

**Bankruptcy** If you file for bankruptcy, you must notify DFAS as soon as possible.

Any unpaid balance of the debt will be automatically reinstated and will become immediately due and payable pursuant to law. DFAS will be entitled to take any lawful action it deems appropriate to collect the debt without duplicating notices and opportunities for review previously provided to me, whether before or after the date of this Agreement. I understand that DFAS maintains the discretion to reject an unacceptable proposed repayment Agreement and proceed with collection by salary offset at the rate of 15%. DFAS will notify me in writing in the event the repayment plan is unacceptable
